Settlement on the purchase of the United Methodist Church property is scheduled for October 4th. We'll hold a celebration the following weekend in conjunction with our annual Yard Sale. Neavitt United Methodist Church Trustees, Reverend Moore and the congregation will be invited to join us.

Glen Albrecht has completed a building inspection and donated his services. Lane Engineering has completed a land survey and examined the site for underground tanks and wells. Eastern Shore Title has done a title search. The Building Inspection has revealed no surprises. Dodson Landscaping will donate the labor for a septic tank if needed. \* \* \*

About fifty people were in attendance and for the most part, the weather cooperated, just one little downpour to set everyone running for the porch. The food was wonderful and a great idea for a fund raiser for the Church project was developed. A cook book featuring the various dishes that are served each year, along with photos, ingredients, directions and the name of the cook could be a great money maker! This was Janet Freidman's idea, so I guess she'll be the one in charge of its development – what do you say Janet? Our guest of honor, Elva Gerlach, who lived in Claiborne between the ages of three and twelve, 1916 to 1928, had a wonderful time reminiscing and sharing stories with us

Thanks Mark for bringing your mom to visit with us and contribute to the festivities! The minutes of the previous meeting on May first were sort of read and accepted. The treasurers report, showing \$1,335.74 in the bank was approved. The fiscal year 2011 budget was passed, showing expected income and expenses of \$73,525. Of this, \$72,350 represents redistricted donations already pledged to be used for the purchase, closing costs, title search, survey, inspection and restoration of the church. The purchase price is set at \$52,000

The following motion was proposed and passed by voice vote: The Board of Directors is authorized to create committees, raise and expend funds, seek donations of goods and services, enter into contracts and agreements that would be required to repair and restore the church property and operate and maintain the property as a community center for the benefit of the Claiborne Community. Jim Richardson will be in charge of heading up this committee.

The Board is further authorized to engage in discussions with the United States Postal Service with the goal of moving the Claiborne Post Office into the community center. The Board will report its progress to the community on a regular basis by providing progress reports at General Meetings and posting information on the Claiborne Website.

After the meeting was adjourned, annual dues were collected and residents were given to ballot to vote for the Officers and At-Large members of the Board of Directors of the Claiborne Association.
