#### Village Center Board News

The County Council voted on July 26 to approve a proposal made by the Village Center Board to amend Talbot County's zoning ordinance for Villages by adding two additional categories to the existing Village Center designation. The legislation will be come effective September 26. The proposal grew out of concerns that the existing zoning designation did not protect village centers from unwanted development. The need for such a change was made clear by a recent case in Royal Oak where the Planning Commission felt it had no choice by to approve a suburban-style development, within the village center, that was opposed by the residents of Royal Oak.

The next step will be for property owners in each of the County's 22 villages to select one of the three designations for their village. Kirke will keep everyone informed about the issue and when the vote will take place. The Village Center had its quarterly meeting on July 7. In addition the VC zoning change the board discussed the county's current moratorium on new subdivisions and received updates on the 2013 Comprehensive Plan revision and planning for the James Michener Chesapeake Country Scenic Byway.

The State of Maryland requires each county to review its comprehensive Plan every six years. Talbot County has decided to review, but not re-write, its plan in 2012. When the current plan was written, in 2005, representatives were chosen from districts in the County. Carol Kabler was one of the representatives from Bay Hundred district. This year the review will be done by chapters. Eight chapter communities have been designated by the old plan. The Community Design and Appearance chapter contains the material on village centers. The 2005 plan did not contain any action items on village centers. The VCB's goal in this review is to include some general information pertaining to all villages taken from existing village center plans. The material contains policy statements on village character and incompatible activities, public facilities, safety and security and strengthening a sense of community.
